

Privacy Policy – Apex Dash FH & FM

This Privacy Policy describes how Apex Dash FH & FM (“the App”) collects, uses, and protects information when you use the application. The App is developed and published by Quentin Rathonie, operating under the commercial name RTH Labs, based in France. Last updated: May 17, 2026

1. Data Collection

The App does not require account creation and does not ask users to provide personal information such as name, postal address, phone number, or email address during normal use. The App uses the following third-party services: • Firebase Analytics (Google) • Firebase Crashlytics (Google) • RevenueCat These services may collect limited technical and usage-related information in order to improve app stability, performance, analytics, and purchase management.

2. Analytics and Diagnostic Data

Firebase Analytics is used in a privacy-focused configuration without advertising tracking or personalized advertising features. Analytics data may include: • App version • Device model and operating system version • General usage events • Anonymous interaction metrics • Country or region-level information • Session duration and performance information Firebase Crashlytics is used to collect anonymous crash reports and technical diagnostic information to help identify and fix application issues. No analytics or diagnostic data is intentionally linked to a real-world identity.

3. In-App Purchases

The App offers optional in-app purchases managed through RevenueCat and Apple’s App Store infrastructure. RevenueCat may process anonymous identifiers and purchase-related information required to validate purchases, restore transactions, and manage entitlements. The App does not directly process or store payment card information. All payment transactions are handled securely by Apple.

4. Local Data Storage

Dashboard settings, customization preferences, and application configuration are stored locally on the user’s device. The App does not use CloudKit or any cloud synchronization service for user settings or telemetry configuration.

5. Data Sharing

The developer does not sell personal data and does not share user data with advertisers or data brokers. Information collected through third-party services is only used for: • Application analytics • Stability and crash reporting • In-app purchase management Third-party providers may process data according to their own privacy policies.

6. Third-Party Services

The App relies on the following third-party services: • Google Firebase Analytics • Google Firebase Crashlytics • RevenueCat • Apple App Store / StoreKit Please refer to the respective providers' privacy policies for additional information.

7. Children's Privacy

The App is not specifically directed toward children under the age required by local law. The developer does not knowingly collect personal information from children.

8. Security

Reasonable measures are taken to protect collected information and ensure the security of the application and its associated services. However, no method of electronic storage or transmission can be guaranteed to be completely secure.

9. Changes to This Privacy Policy

This Privacy Policy may be updated from time to time to reflect changes in the application, legal requirements, or third-party services. Users are encouraged to review this policy periodically.
